



LEGAL CONDITIONS

Deadline for registration

There is no deadline for registration and there are no additional fees during the summer. After 3:00 p.m. on Thursday, you must call the Centre for a registration the following week for day camp or any services.

2026 Discount policy/ Centre Plein Air Fatima Day Camp

Family discount: \$12 off for the 2nd child and any other children from the same family. The child who is registered in the largest number of weeks is the one considered the 1st child.

Services discount: \$10 off when you buy two optional services at the same time (daycare and meals). This rebate doesn't apply for daily services.

N-D-de-l'Île-Perrot resident discount: \$52 off per week per child applicable on all programs at Centre Plein Air Fatima day camp.

Registering a child under a client account that does not belong to an immediate family member (residing at the same address) or for whom you are not the legal guardian constitutes fraud. This would allow someone to benefit from discounts or advantages they are not entitled to, which goes against our policies. Furthermore, please note that the RL-24 slip, required for tax deductions, will be issued in the name of the account holder. Lastly, note that it is not possible to transfer purchases or registrations from one client account to another.

2026 Payment terms

Through internet only via the Centre's website (registration interface powered by Amilia):

1. Online registration fees of \$30 per child, not refundable.
2. Payment option #1: Payable in full in one payment by credit card (Visa/Mastercard).
3. Payment option #2: Payable in payments (40% at registration + balance in equal payments the 19th day of each month from March until June 2026) by credit card (Visa/Mastercard).

Bounced Check or Declined Pre-Authorized Payment

In all cases, a fee of **\$30** will be charged. In the event of an outstanding balance, a written notice will be sent. If the balance is not paid within 15 days and following a review of the account by management, all purchases on the account may be canceled.

Late fee

Any delay in picking up your child at the end of the day will result in a **\$5.00 fee for every 15 minutes late**. These fees will be automatically charged to your Amilia account.

Any early arrival of your child in the morning, if he/she is not registered for daycare, will result in a fee of **\$5.00 per 15-minute period**. These fees will be automatically charged to your Amilia account.

Registration modification

There are no charges for one or more modifications to your registration.

Registration confirmation and downloadable additional information

The paid invoice is a confirmation of the registration. You have the responsibility to download the information in the left margin of the page of the camp selected on our web site.

People who don't have an email will receive their invoice and the additional information by mail (if requested) or in person at reception.

Refund policy

In the event of cancellation of a registration for a day camp program **up to April 20, 2026, at 4:00 p.m.**, no administrative fees will be charged.

For cancellations **after April 20, 2026, at 4:00 p.m. and up to the Friday at 4:00 p.m. prior to the start of the service**, an administrative fee of \$40 per week, per camper will apply and will be non-refundable. After this deadline and once the service has begun, no refunds will be issued.

During camp, if there are any accidents or sickness, the lost days of service will be refunded at pro rata (with a doctor's note).

The costs will be reimbursed in total if the activity is canceled by the camp.
Registration fees are not refundable.

Waiting list

When a group is full, you will be able to put your child on a waiting list. As soon as a spot becomes available, you will receive an email by Amilia to inform you. You will have a short delay to make a decision and no additional fees will be charged except for the difference in cost (\pm) if your child is already registered in another program that same week. Once you have registered, you must contact us if you need to cancel a previous registration in another program.

Returning a camper home

The camp management holds the right to have a camper return home if the child's behavior is deemed unacceptable, and this for the interest of both the camp and the camper. In this case, the refund given will be based on the number of days used, minus the registration fees. You can consult the camper life code in the left margin of the selected camp.

Abusive use of equipment and infrastructure

The camp management holds the right to invoice parents of an offending participant replacement or repair fees for any abusive use of equipment and infrastructure.

Personal effects

The camp management is not responsible for any lost or damaged personal items.

Emergency transport

In case an emergency transport is needed to a health care establishment, the cost incurred will be the child's parents' responsibility.
